2010 Queensland Invitational YOUTH CHALLENGE TEAM



Roll-off for the above team will be held at **CABOOLTURE BOWL** on **SATURDAY 25 July, 2009** and at **SUNCITY BOWL SUNDAY 26 July, 2009**, to finalise teams of **four (4) males** and **four (4) females** to be a representative at the 2010 National Youth Team Challenge which is being held in Victoria at **Werribee Superbowl** from the 11th -15th January 2010.

Representative teams will compete in Singles, Doubles and Teams events in the National Youth Team Challenge. (The Australian Youth Masters will be conducted prior to the National Youth Teams Challenge on the 9th and 10th January, 2010)

Eligibility:

- a) Must be a current financial member of a TBA or Registered Bowling Centre – in good standing.
- b) Must have competed in at least 8 weeks of league and bowled a minimum of 24 games in a TBA Accredited League during 2009 in the State/Territory they wish to represent. (League games completed as pre or post bowling do not count towards the number of games bowled.)
- c) Must be capable of conducting themselves in such a manner so as not to reflect discredit on TBA or Queensland.
- d) Must, unless granted exemption under Rule 6 (f), be resident in the State or Territory for that period of time, which enables them to participate in the respective selection trials of process.
- e) A bowler wishing to represent a State or Territory that is different to the one being resided in at the time of the trials may apply in writing to TBA for an exemption to Rule 6 (e).
- f) Exemptions must accompany this nomination form.
- g) Nomination refunds, if applicable, are at the discretion of the TBAQ Youth Sub-committee.
- h) Must not reach the age of Twenty Three (23) years on the first of January 2010.

The rolloff will be conducted over 8 games Saturday, and 8 games Sunday, it will be a short and long oil patterns during the weekend. Roll-off format may alter, depending on nomination numbers, and at the discretion of the TBAQ sub-committee.

Team selection will be determined by the four (4) highest placed bowlers on pinfall, male and female at the completion of bowling on Sunday 26 July, 2009. Any matters not covered in these conditions will be decided by the TBAQ sub-committee, whose decision will be final.

Please note that the roll-off is an accredited TBA event No. A09/0186

REQUIRED COMMITMENT CLAUSES:

- Attend 3 training sessions this year and a training and bonding weekend on the 2nd and 3rd January, 2010, at the discretion of the coaches.
- You will be required to bowl Sharp Champions Tournament on 14th & 15th November, 2010.
- You must bowl in State or Association Championships
- You are required to arrive at the nominated accommodation by 9.00pm on Friday 8th January, 2010.
